

# GE Vernova and GE Aerospace will become standalone companies on April 2, 2024

According to a press release dated February 29, 2024, General Electric Company announced that its Board of Directors approved the previously announced spin-off of GE Vernova which will begin trading on the NY Stock Exchange on April 2, 2024 as GEV. Holders of GE common stock will be entitled to receive one share of GE Vernova common stock for every four shares of GE common stock held on March 19, 2024. GE stakeholders do not need to take any action to receive shares of GE Vernova common stock. Following the spin-off, GE will operate as GE Aerospace. GE shareholders will continue to hold their shares of GE common stock with the company name GE Aerospace and the listing on the NYSE will be GE. The launch of GE Vernova and GE Aerospace will complete the

transformation of GE into three independent businesses, GE Vernova, GE Aerospace and GE Healthcare. Syracuse Elfun Society does not speak for GE. Since his final retirement, Gary serves on the board of directors for Marcellus Citizens (nonprofit group dedicated to youth activities on our wooded land), Matthew 25 Farm (non-profit farm growing fruits, vegetables, and honey, manned by mostly volunteers) which donates thousands of pounds of produce to needy people via food pantries, churches, etc. all over CNY, and now the Syracuse Elfun Society, serving the community and GE Syracuse alumni.

He also continues to lead and play in the GE Golf League at many local courses.

Gary and MaryLee have been strong supporters of our Elfun chapter and social events for many years, and Gary has offered much insight and advice regarding our activities. We are delighted to have Gary join our board, and we appreciate his input and commitment to our chapter. By the way, Gary provided much more detail than our space allows.
